## 1. Objectives of the MoU

- a) Development of joint education programmes.
- b) Exchange of faculty members and students for mutually agreed duration and terms and conditions.
- c) Joint or collaborative research projects and publications.
- d) Joint organization of technical meetings, international workshops, conferences, seminars, faculty development programs, symposia, etc.
- e) Promoting collaboration in various academic activities.
- f) To encourage students of MNNIT Allahabad to come for higher education and internship at Central University of Himachal Pradesh, Dharashala.

#### 2. Technical Areas of Collaboration

a) To implement a continuing Education Programme to improve quality of staff of MNNIT and IIITA through short-term/long-term certification courses organized by MNNIT/IIITA.

- b) To provide academic interaction through Special Lectures on topics of relevance to industry, starup, skill India, digital India, community development etc.
- c) To enhance the quality and excellence in the field of higher education.
- d) Collaboration in Training and Placement Process,
- e) Organization of joint workshops/conferences and Personality/Professional Development Programmes for enhancement of knowledge and skills of Faculty, Staff and Students.
- f) Offering of elective courses-Joint or individual at either or both institutions.
- g) Joint supervision of M.Tech and Ph. D. Thesis.
- h) Joint International and National sponsored/Consultancy projects
- i) Offering courses on Credit Transfer.

#### 3. Terms and Conditions

- a) This MoU may be amended, renewed and terminated by mutual written agreement of the *Institutions* at any time.
- b) Either Institution shall have the right to terminate this MoU upon ........... days prior written notice to the other institution.

## 4. Confidentiality

- a) MNNIT and <u>Central University of Himachal Pradesh</u> agree to hold in confidence all information/data designated by the *Institutions* as being confidential which is obtained from either institute or created during the performance of the MoU and will not disclose the same to any third party without written consent of the other institution.
- b) The above confidential clause under this MoU excludes the information/data possessed by either institution before entering into this MoU or independently developed and/or information already available through public domain.

#### 5. Duration of MoU

#### 6. Coordinators

Both *Institutions* will designate persons who will have responsibility for co-ordination and implementation of this agreement.

#### 7. Intellectual Property Rights

The Intellectual Property Rights (IPR) that arise as a result of joint research and collaborative activity under the agreement will be worked out on a case to case basis and will be consistent with officially laid down IPR policies of the two *Institutions*.

#### 8. Notices

Any notice to be given under this MOU shall be in writing and shall be deemed to have been duly and properly served upon the Parties hereto if delivered by hand/ Email / Courier / Registered Mail, addressed to the Parties herein at the following addresses or such changed addresses as will be duly notified by the Parties to each other's from time to time: -

#### 9. ARBITATION

Any dispute or differences arising out of interpretation of any of the clauses listed above or otherwise shall be resolved by mutual consultation and if arbitration is needed the matter shall be referred to the Director, MNNIT Allahabad who shall be appoint a Arbitrator to decide the dispute with the consent of other party. The venue of arbitration shall be Prayagraj U.P. and language shall be English. Arbitration proceedings shall be conducted as per Arbitration & Conciliation Act, 1996. The decision of the Arbitrators shall be final and binding on the Parties.

This MoU is executed in duplicate with each copy an official version and having equal legal validity. By signing below, the *Institutions*, acting by their duly authorized officers have cause this Memorandum of Understanding to be executed, effective as of the day and year first above written.
